**RE: Flight Attendants with Priority Return to SLT**

Dear Nena:

This letter sets forth our agreement regarding certain Legacy American Airlines Flight Attendants who are former TWA flight attendants ("Effected Flight Attendants") that were displaced from the St. Louis Flight Attendant crew base. The Parties agree that the following Effected Flight Attendants on the SLT Transfer List, as of June 5, 2018, may exercise priority return to SLT to fill future open vacancies:

Further, this letter constitutes the entire agreement between the Parties with respect to the subject matter of this Letter of Agreement and the Parties agree that the priority return described herein is agreed to on a non-precedent, non-referable basis.


