The APFA PAC allows us to help elect or re-elect candidates that share our priorities, so we make our voices heard in Washington and nationwide!

What is a PAC?

Short for Political Action Committee, a PAC is essentially a separate bank account where your voluntary political contributions are deposited.

Why is it important to contribute to the APFA PAC?

Corporations and their executives have the ability to give big dollars to candidates in elections. While most of us don't have the money individually to donate large amounts to candidates, our small contribution can add up and our voice can be heard.

Are dues monies ever used to contribute to a candidate?

No. All PAC contributions must be voluntary.

How do you determine who will receive PAC contributions?

The decisions for PAC contributions are based on issues that affect American Airlines Flight Attendants. Our focus is the workplace and on our everyday lives. We support candidates who support our values and our issues.

How much do I have to contribute?

There is no minimum amount for either one-time or continuing, payroll deducted, contributions. But by contributing as little as \$2.00 - \$4.00 per paycheck, you can help support APFA's efforts. Remember, the management of air carriers are some of the biggest givers in D.C.
