

DUES :

DUES SHALL BE \$8.50 PER MONTH FOR ALL ACTIVE MEMBERS.

INTITIATION FEE:

INTIATION FEE WILL BE \$10.00 FOR ALL ACTIVE MEMBERS. FOR NEW MEMBERS FEE WILL BE \$10.00 FOR 90 DAYS AND NO MONTHLY DUES WILL BE COLLECTED DURING THE PROBATIONARY PERIOD. UPON COMPLETION OF THE PROBATIONARY PERIOD THE NEW MEMBER WILL BECOME ACTIVE AND SHALL PAY AN ADDITIONAL \$10.00 INTIATION FEE AND SHALL START PAYING MONTHLY DUES OF \$8.50.

ELIGIBILITY FOR OFFICE:

ALL MEMBERS IN GOOD STANDING SHALL BE ELIGIBLE FOR OFFICE AND MUST BE A FLIGHT ATTENDANT TO HOLD AN ELECTED OFFICE. TREASURERS OFFICE NOT INCLUDED.

TERMS OF OFFICE:

BOARD OF DIRECTORS SHALL BE ELECTED FOR AN 18 MONTH TERM OF OFFICE. VICE-CHAIRPERSONS AND COUNCILPERSONS SHALL BE ELECTED FOR A 12 MONTH TERM OF OFFICE.

SALARIES AND EXPENSES:

THE SALARY OF THE PRESIDENT, VICE-PRESIDENT, SECRETARY, TREASURER, AND DIVISION REPRESENTATIVES SHALL BE RECOMMENDED BY THE BOARD OF DIRECTORS AND APPROVED BY THE MEMBERSHIP.

THE EXPENSES SHALL BE BASED ON THE EXPENSES ESTABLISHED IN THE CURRENT FLIGHT ATTENDANT AGREEMENT DURING THE TERMS OF OFFICE FOR MEAL EXPENSES. ACTUAL REASONABLE EXPENSES WILL BE PAID FOR LODGING, TRANSPORTATION, AND TELEPHONE.
